Under section 57 of the *Education Act*, the Lieutenant-Governor in Council, on the recommendation of the Minister, makes the following Regulation:

**Citation**

**1** This Regulation may be cited as the *School Districts and Subdistricts Regulation - Education Act*.

**School districts**

**2** The Province is divided into school districts as set out in Schedule A.

**3** School districts are divided into subdistricts as set out in Schedule A.

**Community names**

**4** The community names listed in Schedule A are

(a) in the case of municipalities continued or created under the *Municipalities Act*, the municipality names identified in New Brunswick Regulation 85-6 under the *Municipalities Act*,

(b) in the case of the municipality created under the *Edmundston Act, 1998*, the municipality name identified in that Act, and

(c) in all other cases, the community names identified in the assignment of civic addresses under the *Emergency 911 Act* and the regulations under that Act.
